Important Notes : 1. The total number of sections of the school shall be restricted to 12 as per the number of sections reported during inspection and numbers of the students are restricted to 32 in 9 sections (as dimension of the same are "between 400 to 500 sq ft") . Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law.

2. The school has converted a staircase into a ramp to access the upper floor, but it is very steep and not as per norms. Therefore, the school is directed to dismantle the same and re construct the ramp/lift to access upper all the floors with the provision laid in RPWD Act and board's guidelines (https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf) within 03 months and submit the compliance. CWSN toilets only at the ground floor are shown, that too are not as per norms as they are very small and narrow with no room for a wheelchair/walker to navigate. The school shall construct separate toilets for CWSN, boys and girls with proper permanent signage, indicating the floor name/number as per norms of RPwD Act and

- guidelines of the Board and submit compliance within 3 months on SARAS.
3. The school has purchased more equipment for composite lab, but the lab is not properly laid out. There are no work stations, only tables on which equipment is placed. no separate reading area for teachers is seen in the library. The school shall upgrade its composite lab and library as per soPs issued by the Board and submit compliance within 3 months on SARAS. Failure to submit compliance of the above conditions will lead to financial penalty against the school.
 4. The school shall conduct training of its teachers with CoE Patna within 3 months and submit the compliance.
 5. The school shall follow the SoPs issued by the Board in respect of labs, library and sports facilities.
 6. The school shall not remove the videography links in the mandatory disclosure section of its website and renew all mandatory certificates from time to time
